1. DEFINITIONS

Tariff	This tariff issued by ASYAD PORTS for defining the payments of charges and dues by the users for using port services
Cargo	Means all types of cargo discharged from vessels and small crafts and all types of cargo loaded to vessels and small crafts or loaded
RO	Means Rial Omani
"Day" and "days"	Means 24 hours and days means time longer than 24 hours
Dry bulk cargo	Means the dry cargo being discharged loose from the carrying vessels or small crafts
Deadweight ton	Means the weight of the cargo equal to a metric ton
General cargo	Means all other cargo which is not defined as a type of cargo specifically in this tariff
Government	Means the Government of Sultanate of Oman and any of representing institutes
Hazardous cargo	Means all the classes of hazardous cargo as governed by the International Maritime Dangerous cargo code published by the International Maritime Organization (IMO) and its amendments time to time.
Liquid bulk cargo	Means the liquid cargo being discharged from the carrying vessels or loaded to the receiving vessels.
Metric ton	Means the weight ton equal to 1,000 Kilograms.
Oman	Means the Sultanate of Oman in its entirety.
ASYAD PORTS	Means "ASYAD PORTS ASYAD Company LLC" duly registered ports management and operating company.
Port Services	All services provided within the Ports managed by "ASYAD PORTS".
Stevedoring	The physical moving of cargo on-board of the Vessels, from or to the Vessel's point of discharge or load and supervision and management of such work
Small crafts	Means wooden dhows, service workboats and towing launches (steel or wooden) irrespective of length overall or size, fishing boats and any other craft with the length overall less than 20 meters
The Port	Means any seaport or maritime terminal managed by ASYAD PORTS



Port User	 Includes the following: any person or entity using the Port facilities any person or entity from whom any service, work or Labor is furnished, performed, done or made available by the ASYAD PORTS for providing port services any person or entity owning or having custody of Cargo moving in, over or through the Port Facilities all Vessels and their owners, operators, crew and agents any other person, firm or corporation that conducts business at the Port facilities.
Ton or Freight Ton	Unless otherwise specified, all "Tons" shall be regarded as "Freight Tons" and shall be determined by a weight Ton of 1,000 kilograms or a measurement of one cubic meter whichever is greater
Vessel	All floating crafts of every description except small crafts as defined in this tariff. In case of tug and barge each one is considered as a vessel for the purpose of billing



2. GENERAL GUIDELINES

2.1. THE TARIFF

This publication (the tariff), published by ASYAD PORTS indicates the tariff of Port Suwaiq and Port Shinas which to be paid by the port users for various usages of port infrastructure and services with effect from 1st April 2018.

Rates, rules, and regulations contained in this Tariff shall apply for all port users equally, unless otherwise specified by written amendment.

2.2. SAFETY

Port users using the port facilities are required to conform to the safety rules and regulations issued by ASYAD PORTS or any local statutory authority.

2.3. HYGIENE

ASYAD PORTS provides garbage skips at various points in the ports for use by vessels. The use of these skips is compulsory.

2.4. PORT RULES AND REGULATIONS

All port services provided subject to following rules and regulations;

- 1. All the laws of Sultanate of Oman as applicable
- 2. "Rules and regulations for sea ports" issued by The Cooperation Council for The Arab States of The Gulf, issued in year 2006 and amendments thereof
- 3. International Maritime Dangerous Goods Code
- 4. International Ship and Port Facility Security (ISPS) Code
- Any other rules and regulation enforced by the governmental authorities or by ASYAD PORTS



2.5. CUSTOMS

The masters of ships on arrival either in the port or at the Anchorage should produce all documents required by the Customs officers of Royal Omani Police, Directorate General of Customs.

All imports and exports of cargo of any sort will be subject to clearance from the Royal Omani police - Directorate General of Customs.

2.6. CIRCULARS

This Tariff and any subsequently issued Tariffs, Circulars, Trade notices or amendments hereof by ASYAD PORTS are to be treated as circulars.

2.7. HAZARDOUS MATERIALS

The Port has regulations concerning the handling of dangerous and hazardous goods and the agents should submit lists of such cargo carried on board prior to vessel's arrival. The Agents or importers or exporters should obtain the clearance as may be applicable from the concerned authorities before the goods are discharged from the vessel or brought into the port. The handling of such cargo will be governed by the International Maritime Dangerous Goods Code published by the International Maritime Organization as listed below.

2.8. CONSENT TO TERMS OF TARIFF

The use of port Services at shall constitute a consent to the terms and conditions of this Tariff and the port users should pay all charges specified herein this tariff as per received port services.

2.9. HELD HARMLESS

Each Vessel Owner or Vessel Operator or Charterer or their Agents whose Vessel calls at port and each Owner or Agent of Cargo handled there within Ports, as a condition to receiving port Services, hereby agrees to indemnify and hold harmless ASYAD PORTS, (any of its agents, servants or employees and any other person, firm or corporation engaged by ASYAD PORTS to furnish labor, materials or equipment relating to provisions of port services) from and against all losses, claims, demands and suits for damages (including court expenses and counsel fees), for death or personal injury or property damage that may be imposed upon the ASYAD PORTS or any of its agents, servants, employees or contractors by any Vessel Owner, Vessel Operator or Charterer or such Cargo Owner (or their agents or employees) as a consequence of Services at the port.

2.10. RESPONSIBILITY FOR DAMAGE TO FACILITIES

All Users of the Port Service facility within the port, or their Agents, shall be responsible for any damage resulting from their use of any of the port facilities within the port and the ASYAD PORTS reserves the right to repair, or otherwise cause to be repaired, all such damage at the expense of such users.



2.11. PORT'S FACILITIES

Means any wharves, docks, piers, sea channels, land, superstructure, pipelines, and extensions thereof and accessories there to, equipment and appliances of all kinds situated within port and owned, operated or leased by ASYAD PORTS.

2.12. ALTERATIONS TO TARIFF

ASYAD PORTS reserves the right to alter, change, or amend from time to time any or all charges, terms, conditions, or interpretations contained in this tariff with or without prior notice.

2.13. ACCESS TO RECORDS

ASYAD PORTS reserves the right of access to all Cargo and passenger manifests, documents and other information relating to vessels or cargo or passengers for verification of reports filed and assessment of charges. Any such information so acquired shall not be disclosed to any person other than a member of ASYAD PORTS in carrying out official duties required as per ASYAD PORTS's internal procedures and upon request to any local law enforcement authority.

2.14. INSURANCE

Charges published in this Tariff do not include any expense for insurance covering the Cargo, passengers, Vessels, or other third-party equipment and liabilities. It is the User's responsibility to provide such insurance coverage.

2.15. TAXATION

The rates indicated in this tariff have not included any government taxes. Any tax enforced by the state taxation authorities will be added to the rates specified in this tariff.

2.16. PAYMENT IN ADVANCE

ASYAD PORTS may at its sole discretion, estimate and collect in advance, all charges which may accrue against any port services provided. Permission to sail of any ship or delivery of any cargo out of the port may be denied until such advance charges have been paid.



2.17. PAYMENT OF INVOICES

Invoices are issued for all the Services rendered to the port users, unless otherwise agreed to in writing between ASYAD PORTS and the user. The user shall pay each invoice submitted to user in full and in cleared funds, within 12 working days after invoice receipt or within the permitted credit period, whatever earliest, to the bank account nominated by ASYAD PORTS or any other means of payment specified by ASYAD PORTS time to time.

2.18. WORKING HOURS

- Administration office working hours are from 0700 hours to 1600 hours during Sunday to Thursday (both inclusive), excluding Fridays, Saturday and Public Holidays.
- 2. Port Services will be provided subject to necessity of the service and the work timing will be defined by ASYAD PORTS after considering the required work. For the purpose of invoking, it is considered "the Normal working hours" are from Sunday to Thursday (both inclusive) are from 0700 Hours to 2300 Hours on each day. Any service provided out of normal working hours including Fridays, Saturdays and public holidays must be prearranged with ASYAD PORTS and subject to "overtime charges".
- 3. Port services provided out of normal working hours from Sunday to Thursday and during Fridays, Saturdays and public holidays are consider as "overtime work" and such overtime charges for various services are specified against each applicable tariff item in this tariff.

2.19. SHIPPING AGENTS

Each vessel or small craft arriving at the port for any kind of service should have a local agent appointed to represent the ship. The agent is liable for local authorities and to ASYAD PORTS for provisions of necessary information, payments of charges and attend all other affairs related to the vessel's or small craft's port call.

After declaring a vessel or small craft for calling at port by an agent, the agent is bound by all terms and condition mentioned in this tariff. The agent cannot get relieved from all liabilities, responsibilities and obligations unless another agent is appointed to represent the subject vessel and all related liabilities, responsibilities and obligations are undertaken by the new agent.



2.20. NOTICE OF ARRIVAL

The Master of vessel or small craft, through the appointed local agent should provide Expected Time of Arrival (ETA), Length overall (LOA) of the vessel or small craft and draft of the vessel or small craft and any other information requested to Harbor Master of the port by mail or fax 72, 48 and 24 hours prior to arrival at the port.

2.21. DOCUMENTS

The following documents should be submitted to ASYAD PORTS electronically, at least 42 hours prior to Vessel's or small craft's arrival by the shipping agent or the master through the shipping agent.

Failure to do so may result in withholding of vessel's or small craft's clearance to berth or sail from the Port, until they are made available.

ASYAD PORTS may exempt any of the above requirement if such requirement is not necessary.

2.22. PORT ACCESS

Access to the ports will only be granted by ASYAD PORTS after written request by port users. Any port user expecting to dock a vessel or a small craft at the Port for embarking or disembarking passenger, loading or discharging of cargo or for any other permitted purpose, must provide such



information to ASYAD PORTS as specified in this tariff, as specified in the port rules and regulation and as may be requested by ASYAD PORTS incidentally.

2.23. VACATE A BERTH

ASYAD PORTS reserves the right to instruct a vessel or small craft to vacate its allocated berth on completion of declared operations activities or any other reason. The User is obligated to meet the request at its own expenses.

2.24. CHARGES NOT SPECIFIED

Usage of port facilities or services provided for which a charge is not specifically stated in this tariff will be fixed by ASYAD PORTS at its discretion.

2.25. USE OF FACILITIES

ASYAD PORTS reserves the right to designate and regulate the use of all facilities within port areas. ASYAD PORTS reserves the right to refuse or accept providing port services due to any justifiable reason subject to the laws, rules and regulations mentioned at section 4.1 of this tariff.

Placing or using, within the port areas, of any equipment or accessories own by port users is prohibited unless prior permission has been obtained from ASYAD PORTS to do so and payment of any applicable charges as stipulated are done. It is the sole responsibility and liability of the user of such equipment or accessories to compensate for any injury to persons or damage of whatever nature, including damage to property of Operator and other third parties. All such equipment or accessories brought in ports should be fully covered for third party liability under owner's insurance policy.



3. PORT DUES AND CHARGES

3.1. PORT DUES

- Port dues will be assessed from the time the vessel arrives at the anchorage till the time
 she leaves the anchorage area and sails out on all vessels berthing within the Port for
 discharging or loading of cargo or embarking and disembarking of passengers or any other
 purposes.
- 2. The charges will be based on either Gross Tonnage (GT) or Length Overall (LOA) of the vessel, as found in the Lloyds Register of Shipping or other recognized register at the option of ASYAD PORTS. The charge covers the ports' marine radio and port control services, the provision and maintenance of navigational aids. All charges, contained in items no. 310 to 312 shall be billed to vessels' Agents

3.2. ANCHORAGE DUES

1. Anchorage dues will be levied on all vessels lying at anchorage within port limits which do not require to be berthed which to be paid by the vessel's agent.



2. The charges are applicable per day or part thereof as specified in the table below:

3.3. SMALL CRAFTS' PORT DUES

Below charges will be levied on all small crafts calling at anchorage or requiring to be berthed.

3.4. TUGBOAT HIRE CHARGES

- 1. Tug hire charges will be applied;
 - a. For all vessels berthed at Port
 - b. For all vessels shifting from berth to berth within the port
 - c. For all vessels shifting from berths to anchorage
 - d. For all vessels shifting from anchorage to berths
- 2. The charges are applicable per tug per hour or part thereof, subject to minimum 3 hours per call or per shifting.
- 3. The tug boat hire charges will be increased by 50 % on Fridays, Saturday, and all Public holidays.
- 4. The Tugboat hire charges, will be increased by 100 % for vessels whose engine does not work fully or partially.
- 5. The Tugboat hire charges will be increased by 50 % for vessels carrying hazardous materials on board including military vessels having arms and ammunition on board. No additional premium charges are applicable on this item on account of Fridays, Saturday, and all Public holidays.
- 6. The charges as shown in the table below

3.5. Pilot HIRE CHARGES

- 1. Pilot hire charges will be applied;
 - a. For all vessels berthed at Port
 - b. For all vessels shifting from berth to berth within the port
 - c. For all vessels shifting from berths to anchorage
 - d. For all vessels shifting from anchorage to berths
- 2. The charges are applicable per pilot per hour or part thereof, subject to minimum 3 hours per call or per shifting.
- 3. The Pilot hire charges will be increased by 50 % on Fridays, Saturday, and all Public holidays.
- 4. The Pilot hire charges, will be increased by 100 % for vessels whose engine does not work fully or partially.
- 5. The Pilot hire charges will be increased by 50 % for vessels carrying hazardous materials on board including military vessels having arms and ammunition on board. No additional premium charges are applicable on this item on account of Fridays, Saturday, and all Public holidays.
- 6. The charges are as shown in the table below

3.6. LINESMEN HIRE CHARGES

- 1. Linesmen hire charges will be applied
 - a. for all vessels berthed at the port
 - b. for all vessels shifting from berth to berth within the port
 - c. for all vessels shifting from berths to anchorage
 - d. for all vessels shifting from anchorage to berths
- 2. The charges are applicable per gang, per hour or part thereof, subject to minimum 2 hours per call or per shifting
- 3. The Linesmen hire charges will be increased by 50 % on Fridays, Saturday, and all Public holidays.
- 4. The Linesmen hire charges will be increased by 50 % for vessels carrying hazardous materials on board including military vessels having arms and ammunition on board.
- 5. The charges are as shown in the table below

3.7. POLLUTION CONTROL CHARGES

- 1. Pollution control charges are applied to all vessels and small crafts calling the port, both at berths and at anchorage as shown in the table below.
- 2. The charges are applicable per call, per each 5 days or part thereof.



3. For the vessels or small crafts berthed alongside, having hazardous materials on board including military vessels having arms and ammunition on board, the charges will be increased by 50 %.

3.8. PROVISIONS OF GARBAGE SKIPS

ASYAD PORTS provides garbage skips in the ports for the vessels to dispose small quantities of nonhazardous, solid garbage such as kitchen wastes, cabin waste etc. Usage of garbage skips for disposing garbage is compulsory. The provisions of garbage skips are subject to below charges

3.9. PASSENGER LEVY AND TOURIST LEVY

- 1. Passenger and tourist levy are applicable to
 - a. Ferries carrying passengers
 - b. Tourist dhows
- 2. Passenger and Tourist levy is applicable to each passenger joining or leaving afore mentioned ships, including passengers in transit who use Port Facility to go ashore and return.
- 3. Military vessels will be charged as a lump sum per call basis; hence not by the count of number of crew embarked or disembarked.
- 4. The charges are as shown below.

4. CARGO HANDLING CHARGES

4.1. BULK CARGO

- 1. The vessel's agents and the ship master are responsible, at their cost, to ensure that all safety measures are taken to protect the environment while discharging any bulk cargo.
- 2. The vessel's agent or consignee or shipper shall be responsible to arrange, at their cost, necessary equipment required for the operation.
- 3. The vessel's master or vessel's agent shall be fully responsible to maintain the quay and the operational area from any kind of spread of residues; dust etc. as the result of the operation, at their cost.
- 4. All charges as mentioned in the table below are invoiced to agent or collected directly from consignee or shipper at the discretion of ASYAD PORTS.

4.4. STORAGE CHARGES

5.3. PORT DOCUMENTATION AND CHARGES

The Port users should abide by following port documentation concerning berthing of vessels and small crafts and clearance of cargo.

5.3.1. BERTHING OF VESSELS

Vessels and small crafts will not be berthed unless the following documents are received at least 24 hours prior to the arrival.

- 1. 2 copies of Cargo Manifest (Cargo vessels)
- 2. 2 copies of passenger manifest (Cruise vessels)
- 3. 2 copies of Dangerous Cargo List / hazardous cargo including Arms and ammunition onboard the vessel
- 4. copy of Vessel arrival notice with details of the vessel (Flag, draft, Length overall and gross tonnage

5.3.2. PORT CLEARANCE

ASYAD PORTS issues port clearance for each vessel either called at anchorage or berthing alongside the port, before departure. Port clearance charges are applicable per call of vessel as shown in table below.

5.4. DOCUMENTATION CHARGES

Import Cargo clearance will be allowed subject to submission of following documents

- 1. Agent's Delivery Orders (DO),

- 3. Other cargo related information's such as dangerous cargo declarations and any other declarations
- 4. Customs Declaration and approval from Royal Omani Police Customs
- 5. Health and quarantine certificate / approvals issued by Local authorities
- 6. Any other clearance from the authorities depending on nature of cargo
- 7. Cargo Charges and Removal Order (CCRO) from the ASYAD PORTS's cargo clearance office

Export cargo will be allowed to enter the port subject to submission of following documents

- 1 Export Pre-advices from the ASYAD PORTS's cargo clearance office
- 2 Shipping agents request for acceptance of cargo per intending loading ship
- 3 Customs Declaration and approval from Royal Omani Police Customs
- 4 Any other clearance from the authorities depending on nature of cargo
- 5 List of Goods to be loaded with details as to the number of packages, Deadweight tons and Cubic meter of each package.
- 6 Other cargo related information's such as dangerous cargo declarations and any other declarations

Documentation charges are collected from the relevant port user i.e. Consignee or shipper.

6. PORT ENTRY PASS

6.1. ACCESS CONTROLLED AREA

All the ports managed by ASYAD PORTS are custom bonded area; hence access to persons and vehicles is strictly controlled. Persons and Vehicles entry to Ports purely subject to approval and permission from Royal Omani Police and ASYAD PORTS.

6.2. TYPE OF GATE PASSES

ASYAD PORTS issues different gate passes to match with business requirement. Separate gate passes are required for individuals and vehicle. All gate passes are issued subject to payment of charges as mentioned in this tariff.

6.2.1. TEMPORARY PASSES

- 1. Temporary passes are issued for a period of one day, one week and one month, as applicable, subject to approval of ROP.
- 2. Visitors to port required to submit their application to ASYAD PORTS in the prescribed form.
- 3. Truck drivers, for cargo clearance are issued gate pass against production of valid CCROs or Pre-advice document.

6.2.2. PERMANENT PASSES

ASYAD PORTS issues permanent passes at their discretion, on receipt of a letter and application form with supportive document listed below from concerned showing that the applicant has legitimate and frequent business in the Port. Gate passes can be obtained valid for 6 months or valid for one year. However, validity of gate will end with expiry date of resident card or identity card.



- a. Company Letter regarding the work to be undertaken in the secured port area
- b. No Objection Certificate from the Company for authorization.
- c. Copy of residence Card & 2 Photos
- d. Copy of Specimen signatory

6.3. PASSES FOR VEHICLE

All vehicles entering port (excluding the exempted vehicles) are required to have a gate pass from ASYAD PORTS subject to endorsement of Royal Omani Police.

6.3.1. EXEMPTION OF GATE PASSES

A. Individual gate passes

Port entry fee is exempted for below individuals:

- a. Personals or officials of ministries and other governmental authorities visiting the port
- b. As ASYAD PORTS may decide time to time
- B. Vehicle gate passes

Port entry vehicle gate pass fee is exempted for below vehicles;

- a. Vehicles of Government Institutions under service of Sultanate of Oman
- b. As ASYAD PORTS may decide time to time
