



Registrations and Licensing

Muscat Airport Free Zone offers two entity formation types designed to meet diverse business requirements. Choose the one that suits your needs and start your journey with ease.

Free Zone Company (FZC)

FZC- This type of entity formation is principally Limited Liability Company (LLC) within Muscat Airport Free Zone. Registration as FZC permits the investor for a multiple shareholder.





Licenses

The type of license you need to operate at Muscat Airport Free Zone depends on the activity your business participates in. There are four groups of licenses.



Commercial License

Covers import, re-export, storage, and distribution of goods within the free zone, including repackaging without altering the original condition of goods.

Industrial License

Applies to manufacturing and remanufacturing activities that modify or enhance the quality of goods within the free zone.

Service Provider License

Includes logistics, consulting, administrative, and other professional services tailored to free zone operations.

Real estate

Covers construction, operation, and rental of residential, commercial, and service-related buildings within the free zone.
